Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to X shall be restricted to 36 The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by elaw and availability of class rooms of greater than 500 sq ft dimension.
2	The school has only 37 classrooms as per prescribed dimension and not running bal-vatika. Thus, school is required to construct 02 more classrooms to run bal-vatika (as per sl. No. 1) and submit an undertaking on its letterhead that it will run the bal-vatika in the upcoming session within 03 months in the compliance
3	The school has submitted the revised land certificate, however details of the lessor with land title still not mentioned in the said certificate. Further, stamp of the issuing authority is not properly legible. Thus, the school is required to obtain revised land certificate as per format (appendix – X, prescribed in circular no., 2012/2022) issued by concerned competent land/revenue authority with complete details of both the parties i.e. lessor and lessee within 03 months and submit the same in the compliance.
4	The school has submitted an undertaking in the compliance, citing that schools' corrected land area is 28516 sq mtrs. Thus, the school is directed to apply for correction in land in the SARAS Portal and submit an undertaking in this regard within 03 months in the compliance.
5	The school has submitted documents though email dated 29-02-2024 i.e. (i) permanent recognition certificate (ii) society registration certificate (iii) a request letter dated 23-11-2023 for removal of HT lines (iv) an undertaking dated 29-02-2024 with regard to removal of HT lines. Thus, the school is required to submit the all the documents in the compliance on SARAS portal within 03 months.
6	The school is directed to cordon off area where electrical poles are located for safety of the students and school's personnel within 03 months and submit the videography evidence within 03 months.
7	The school is required to complete the construction work, develop its playground and raise the height of the boundary wall (with minimum 6 ft) within 03 months and submit the videography link covering entire boundary wall from all sides in continuity within 03 months and submit the compliance.
8	The fire safety certificate does not have the correct land area. Thus, the school is required to obtain renewed certificate with corrected details and submit the same in the compliance within 03 months.
9	The school has two blocks. However, in the building & fire safety certificates there is detail of only one block. Thus, the school is directed to not to use the other building block for any academic activities before getting renewed building and fire safety certificate as well as Board's Approval and submit an undertaking in this regards on school's letterhead within 03 months in the compliance.
10	The school has converted regular cubicles into CWSN toilets, but they are very narrow and there is no room for a wheelchair/walker to navigate. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance
11	The composite science lab is set-up on the make-shift tables. It does not have permanent fixtures, washbasin (with water tap) as well as gas connection in the workstation and exhaust fan. Thus, the school is required to set-up as per Board's SoP within 03 months and submit the compliance.
12	The library is poorly managed with unsuitable furniture (desks) and it does not have separate reading space for staff. Thus, the school is required to upgrade the library within 03 month and submit the in the compliance
13	The school is required to maintain the minimum requirement of the computers i.e. 40 in the computer lab within 03 months and submit the videography evidence in the compliance.
14	The school shall conduct training of its teachers with CoE Prayagraj within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

- The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated
 04 10 2022

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
